

1. \$1,000 Workday Payday Contest Dates: 4/1/19 – 5/3/19

2. NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

3. Contest is open to legal residents within the KCML---FM St. Cloud metro survey area (as defined by Nielsen), 18 years of age or older, with a valid driver's license, passport or other government---issued I.D., with the exception of employees and the immediate families of KCML---FM and their partners, affiliates, subsidiaries, promotion sponsors or agencies. Limit one entry per person, per day. KCML reserves the right to forfeit contestants if multiple entries per day are sent and/or the entry system is abused.
